## **TERMS & CONDITIONS:-**

- 1. Interested applicants are advised to go through the Eligibility Criteria carefully and ascertain themselves regarding their eligibility.
- **2.** (i) Short listing of candidates for the panel will be based on scrutiny of documents of their age, qualification, experience etc. and meeting eligibility prescribed criteria. Merit will be decided on the basis of their qualification, experience, achievements/past performance and interaction with Interview Board.
- (ii) Finally selected candidates will be considered for engagement on purely part time contractual basis for a fixed period or till expiry of the contract or until further orders.
- **3.** No TA/DA will be provided to candidates for appearing for the Interaction/documents verification etc., when called.
- **4.** The place of deployment will be anywhere in NDMC area. No conveyance or conveyance allowance will be paid by NDMC.
- **5.** Candidates must produce original documents in respect of Date of Birth, Qualifications, Achievements and Experience as per eligibility criteria on the date of document verification and interview/interaction, otherwise they will not be allowed to appear in the interview/interaction.
- **6.** The details of the candidate in the application form must be the same as mentioned in Class 10th Certificate, PAN Card/ Aadhar Card. In case the candidate has changed his/her name subsequent to Class 10th, the evidence to that effect should be furnished at the time of interaction/documents verification also.
- **7.** Canvassing/trying to influence in any manner to secure the engagement shall disqualify the candidate.

- **8.** NDMC has right to accept or reject the application(s) without assigning any reason thereof.
- **9.** NDMC has the right to withdraw or modify this advertisement at any time without any notice.
- **10.** Candidate must furnish correct information regarding age, qualification and experience while submitting the form online.
- 11. Incomplete application shall be summarily rejected.
- **12.** Candidate must keep on watching NDMC website (www.ndmc.gov.in) for any Corrigendum/notification in respect of this engagement.
- **13.** In case the information filled in the online form is incomplete and not matching with the prescribed criteria, the application will be rejected and NDMC will not be liable to call them for document verification/any round of screening thereafter.
- **14.** In case at any stage of recruitment process the documents/information provided by the candidate is found fake or misleading, the candidature is liable to be rejected.
- **15.** Merely fulfillment of eligibility criteria does not entail the candidates to be called for the interview.
- **16.** The eligible/shortlisted candidates shall be informed through email and SMS regarding schedule for interview i.e. Date, Time and Place.
- 17. The candidates should note that their candidature at all the stages shall be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any stage before or after interview, it is found that they do not fulfill any of the eligibility conditions, their candidature shall be rejected by the NDMC.
- **18.** The term international participation in eligibility criteria, means having represented the country in the international competition at Senior Level in Sports discipline recognized by World Body of the respective Sports such as:-

- i. Olympic Games
- ii. World Championship/World Cups
- iii. Asian Games
- iv. Commonwealth Games
- v. Asian Championship/Asia Cup etc.
- **19.** A panel of **Coaches** on contract will be drawn on the basis of criteria as mentioned above. The panel may have names more than the current requirement for the purpose of use in future.
- **20.** The engagement of **coaches** on contract basis shall not confer them any right for regularization or absorption of appointment on regular basis.
- **21.** The Coaches will be paid a fixed monthly remuneration of Rs. 32,777/- per month for 4 hours a day and 6 days a week for part time engagement.
- **22.** There will be no restriction on the coaches, if they are employed in any organization beyond the NDMC coaching timings. However, such engagement should not come in the way of their duty and performance in training/coaching the school students under proposed engagement in NDMC.
- 23. The tentative timings of coaching would be as under:
  - a. March to September:

4.00 pm to 8.00 pm

b. October to February:

3.00 pm to 7.00 pm

- **24.** Decision of NDMC in all matters regarding eligibility, selection and posting would be final and binding on all candidates. No representation or correspondence will be entertained by NDMC in this regard.
- **25.** NDMC reserves the right to modify/alter/restrict/enlarge/cancel the recruitment process, if need so arises without assigning any reason thereof. Decision of Education Deptt., NDMC shall be final and no representation will be entertained.
- **26.** The other terms and conditions necessary for engagement in NDMC will be mentioned in the detailed agreement that shall be signed by the selected candidate at the time of engagement.
- 27. Termination: The contract can be terminated by giving a 30

days' notice period by either party i.e. NDMC and the engaged Coach. In extreme cases, the contract can be terminated by NDMC with immediate effect without notice period.

- **28.** Applications received after due date are liable to be summarily rejected. NDMC will not be responsible for any delay in submission of online application form due to any reason.
- **29.** The applicant must bring all the certificates w.r.t. achievement as a Coach, Coaching Experience/Sports discipline, Achievement as Player, Educational Certificates, age certificate and Coaching Certificates at the time of document verification and interview/interaction.
